The CAMMPACAMM Story

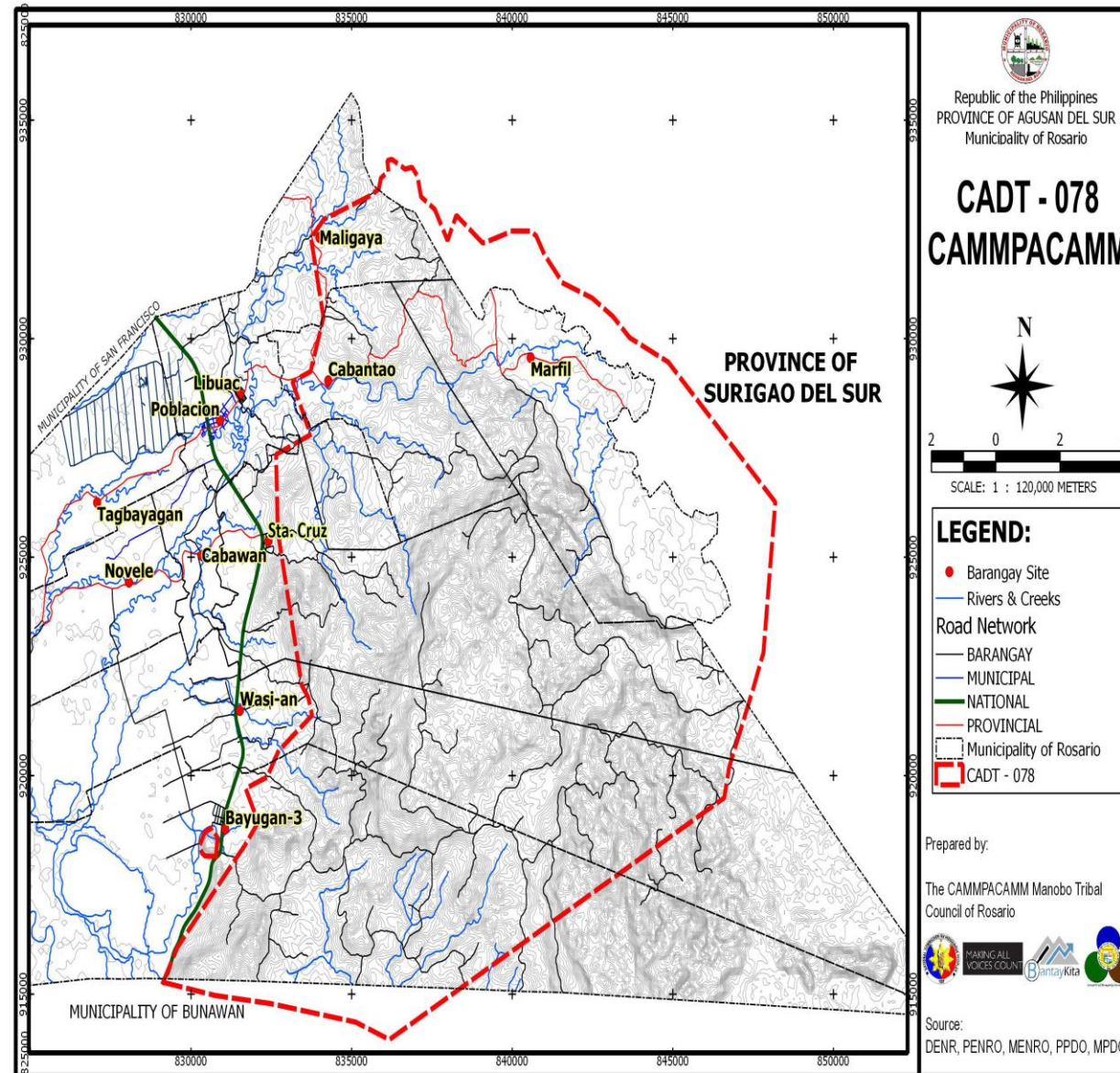


CAMMPACAMM is an IPO that is based in Rosario, Agusan del Sur.

CAMMPACAMM is the Holder of CADT 078

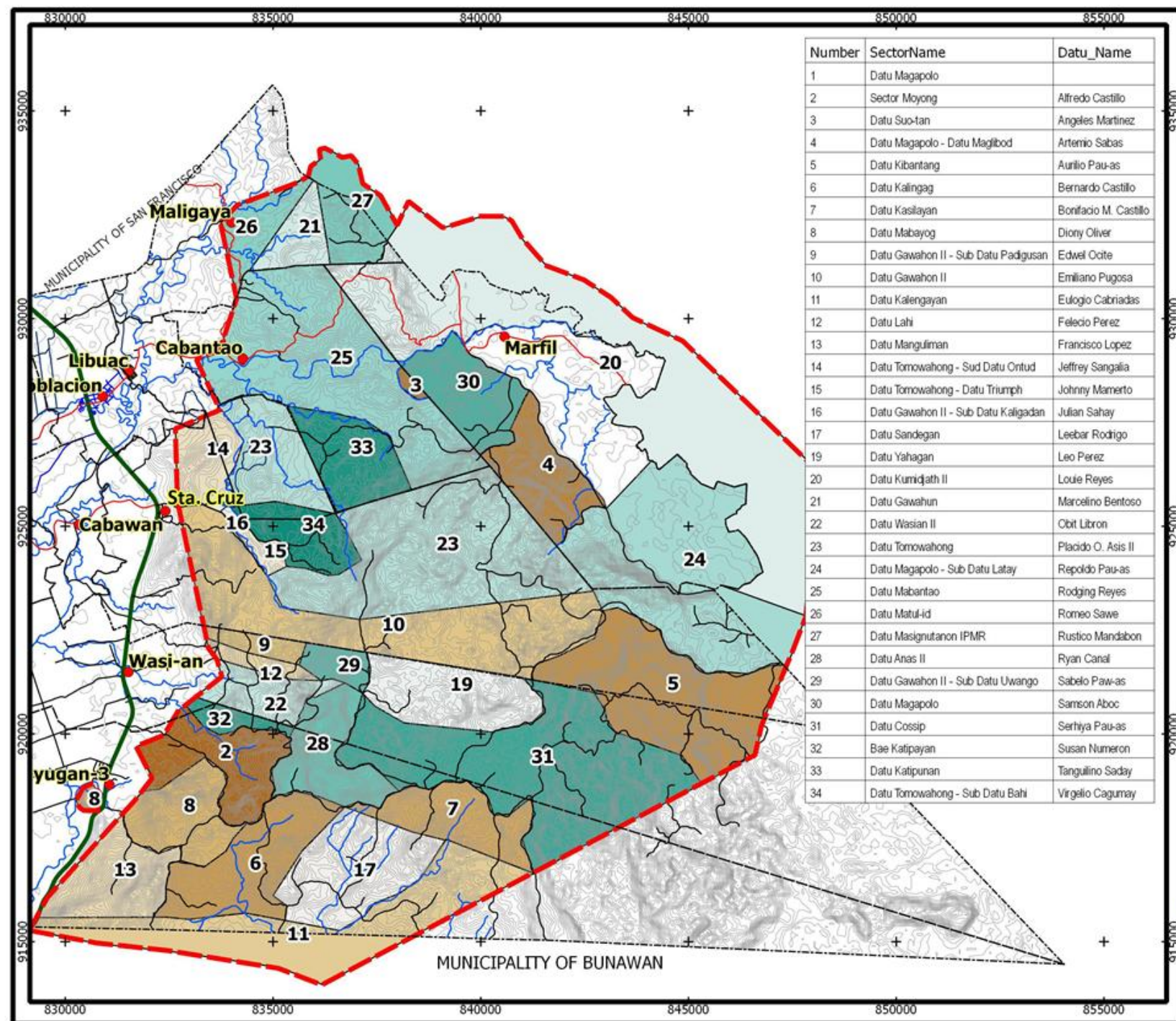


We made sure that we would have ADS DPP and we endeavoured to act as a responsible IPO.
